General Purpose

Performs routine public safety work to ensure the safe passage of school-age children across heavily traveled streets and intersections while enroute to and from school.

Supervision Received

Works under the supervision of the police department day shift supervisor.

Essential Duties and Responsibilities

Maintains a presence at assigned intersection each day that school is in session at the times assigned: during a typical school year, these times are usually between 7:25 AM – 7:50 AM in the morning and 3:25 PM – 3:50 PM in the afternoon. However, the starting/ending times may vary with late starts and early release days based on the school schedule as determined by Austin Public Schools, but is typically during the one hour prior to the start of the school day and one hour at the end of the school day.

Scheduled half days would require the second session time to be modified.

Monitors school schedules during inclement weather and reports to assigned location in the event that school is dismissed early.

When traffic permits, gets into traffic with flag to assist children in crossing the street.

The duties listed above are intended only as illustrations of the various types of work that may be performed. The omission of specific statements of duties does not exclude them from the position if the work is similar, related or a logical assignment to the position.

Minimum Qualifications

Education and Experience:

High school diploma or GED equivalent;

Necessary Knowledge, Skills and Abilities:

- A. Ability to establish and maintain effective relationships with young children;
- B. Ability to exercise sound judgment in evaluating situations and in making decisions;
- C. Ability to follow verbal and written instructions;
- D. Ability to function independently yet accept supervision as required;

E. Ability to effectively deal with the public, using tact and sound judgment.

Special Requirements

Successful completion of background check.

Tools and Equipment Used

Crossing guard flag.

Physical Demands
