

ORDINANCE NO. 748

**AN ORDINANCE OF THE CITY OF AUSTIN, MINNESOTA
AMENDING CITY CODE SECTION 2.71 AND RENUMBERING CITY CODE
SECTIONS 2.71, 2.72, 2.73, 2.74, 2.75, & 2.76**

The Council of the City of Austin does ordain:

Section 1. Austin City Code Chapter 2, Section 2.71 is hereby renumbered as Austin City Code Chapter 18, Section 18.02 and amended as follows:

§ 18.02 PARTIAL PRE-PAYMENT OF SPECIAL ASSESSMENTS.

Subd. 1. *Partial prepayment of assessments permitted.* After the adoption of an assessment roll pursuant to M.S. Chapter 429, as amended, and before certification of the assessment roll to the County Auditor, the City Administrator or other authorized official is authorized and directed to accept partial prepayment of the assessment, but not less than 50% of the total amount of any assessment and reduce the amount certified to the County Auditor accordingly. ~~As provided by law, the~~ The partial prepayment may be accepted only during the 30-day period following approval of the assessment roll by October 31st in the year of the adoption of the assessment roll.

Subd. 2. *Scope.* This section shall apply to all assessment rolls which, on the effective date hereof, have been adopted by the Council, but not yet certified to the County Auditor, and to all assessment rolls subsequently adopted by the Council.

Section 2. Austin City Code Chapter 2, Section 2.72 is hereby renumbered to Austin City Code Chapter 2, Section 2.71.

Section 3. Austin City Code Chapter 2, Section 2.73 is hereby renumbered to Austin City Code Chapter 2, Section 2.72.

Section 4. Austin City Code Chapter 2, Section 2.74 is hereby renumbered to Austin City Code Chapter 18, Section 18.03.

Section 5. Austin City Code Chapter 2, Section 2.75 is hereby renumbered to Austin City Code Chapter 2, Section 2.73.

Section 6. Austin City Code Chapter 2, Section 2.76 is hereby renumbered to Austin City Code Chapter 2, Section 2.74.
