Item No. 1 – I-90 Bridge Replacement Project

Public Works Director Steven Lang introduced Dave Nelson and Jai Kalsy with MnDot. They provided an overview of the upcoming bridge projects in the City of Austin.

Dave Nelson and Jai Kelsey reviewed each project and the specifics of each bridge. The 4th Street project is anticipated to begin in 2024. They also reviewed the municipal consent process. The Council will need to pass a resolution to approve the right of way plan and construction project for the bridges. He stated they are working on applying for federal funding for the bridges.

Item No. 2 – 1704 4th Street SW Appraisal Review

Public Works Director Steven Lang stated the City was approached about purchasing the property at 1704 4th Street SW as a flood buyout. He stated the homeowners turned down an offer from the City via grant in the amount of \$182,000 in 2014. The only year it flooded was 2004.

The property is currently valued at \$328,000. There is no grant funding available from the DNR at this time so it would be 100% funded with Local Option Sales Tax. Mr. Lang recommended not purchasing the home at this time due to the high cost, no availability of a grant and limited flooding impact to the property.

The Council agreed with Mr. Lang's assessment of the situation. No additional Council action needed at this time.

Item No. 3 – Airport Zoning Board

Planning and Zoning Administrator Holly Wallace stated the zoning needs to be updated around the Austin Municipal Airport. The consultant on the project has recommended the establishment of a joint zoning board with the County and the townships. The Council will need to appoint someone to represent the City of Austin on the board.
