# <u>Item No. 1 – I-90 Bridge Replacement Project Update</u>

Public Works Director Steven Lang stated he recently received updated funding projections for the I-90 bridge replacement project. He stated the Hormel Foundation is funding the community entrance sign in the amount of \$175,021. The WWTP fund is estimated to pay \$67,616 and the Municipal Street Aid Fund is project to pay \$610,883 for the project. He reviewed the project by bridge and the funding thereof.

Council Member Postma stated he would like to be involved with the design of the sign.

Mr. Lang stated in 2015 a group was formed for the visual quality manual for the bridges and other improvements, including the sign. He stated that manual has been approved by MnDot and it is too late for major changes to the sign. He added that it is difficult to make changes this late in the process.

The Council discussed the proposed welcome sign and the necessity for it.

Director of Administrative Services Tom Dankert stated the Gateway to Austin committee originally designed the bridge improvements and they were approved by the Hormel Foundation.

Moved by Council Member Baker, seconded by Council Member Fischer, to remove the sign from the project. Motion failed 5-2.

Mr. Dankert noted that prior Councils have committed to the project.

Mayor King agreed that the City should honor the past commitments.

For Council information only; no action needed at this time.

## Item No. 2 – Policy for Affiliation with Outside Agencies

City Attorney Craig Byram presented a proposed policy for employee affiliation with outside agencies. He stated the state law is ambiguous as to if employees should be accepting mileage reimbursement or other reimbursements from outside agencies. He stated the outside group must be affiliated with the scope of the employee's job duties. The benefit allowed to accept required to be nominal such a mileage, hotel, food cost, per diem, would not be an hourly wage or salary, The outside agency membership must be approved by your supervisor to make sure City functions are still being completed. The employee must disclose if there are changes to the reimbursement.

Council Member Baker was concerned about organizational consistency for the policy.

Mr. Byram stated the policy would set the parameters for employee participation in outside groups.

After additional discussion, the Mayor directed Craig Clark to discuss the policy at staff meeting and to report back to Council.
