COMMON COUNCIL SPECIAL MEETING
June 11, 2002
6:00 P.M.
Lower Level Conference Room

MEMBERS PRESENT: Mayor Rietz, Council Member-at-Large Chaffee, Council Members Goodnature, Jorgenson, Christopherson, Nordin and Lang.

MEMBERS ABSENT: Council Member Poppe.

OTHERS PRESENT: Media.

City Engineer Jon Erichson discussed the bids that were received for three different street construction projects. In 2002, the public hearings on the projects were held prior to letting bids. Only one objection was received, and this individual has now withdrawn his objection.

The first project is for street re-construction in the area of the new arena. One bid was received from Ulland Brothers for \$582,865.11, which was approximately \$5,000 less than the Engineer's Estimate. Mr. Erichson noted there was only one bid as this is a difficult job to complete. Council Member Christopherson asked when the start date on this project would be. Mr. Erichson noted the pre-construction meeting will be Thursday, with an actual construction start date in July.

Moved by Council Member Christopherson, seconded by Council Member Nordin, adopting a resolution awarding the bid to Ulland Brothers. 6-0. Carried.

Bids have been received for street project 5-A-02 (8th Street SW and 3rd Avenue SW). Bids came in below the expected cost. There was one bid that was not valid as acknowledgement of an addendum had not been made. The Engineering Department is recommending the bid of Doyle Conner Company at \$863,145.53. The bid list is as follows:

Bids have been received for street project 6-A-02 (6th Avenue SE and 9th Street SE). Bids came in below the expected cost. The Engineering Department is recommending the bid of Ulland Brothers at \$309,020.35. The bid list is as follows:
