Council is requested to approve an annual resolution designating depositories for checking and investments for 2012. One change has been made to the depositories which is closing the payroll account; the one remaining direct deposit account will be re-routed to another account.

Moved by Council Member Boughton, seconded by Council Member Enright, adopting a resolution designating depositories for checking and investments of public funds for 2012. 7-0. Carried.

Moved by Council Member King, seconded by Council Member McAlister, designating Austin Post Bulletin as the official newspaper for the City of Austin for the year 2012. Carried.

Council is also requested to approve an annual resolution setting the licensing and operational fees for 2012. Council Member Enright questioned why the fees weren't more consistent. City Attorney David Hoversten said that pursuant to state statute, the city council must fix fees with a reasonable relationship to the cost. For example, some licenses require investigations while others do not.

Council Member Clennon believes we are lenient with the animal licenses considering they are permanent. She suggests raising the non-spayed dog and cat licenses to \$50. Mayor Stiehm said one requirement for dog park visitors will be city licensing, and they would need to be renewable annually.

Council Member King questioned the disparity between spayed and non-spayed licenses since these licenses require the same amount of work. Mr. Hoversten said that is an argument, but the general principle applies.

Council Member Austin said perhaps we should change this license to non permanent. The discussion should be brought to a work session.

Council Member McAlister felt that licensing animals is primarily for identification and he guesses that most animals are not licensed. He believes that if we raise the fee, people will be less likely to get a license for their animal. And if they aren't permanent, people will be even *less* likely to obtain a license.

Mayor Stiehm said he would like to receive input from organizations that have done this, and we should schedule this discussion as soon as possible.

Moved by Council Member Boughton, seconded by Council Member McAlister, adopting a resolution establishing and fixing license and miscellaneous operational fees for 2012. 6-1. Carried. Council Member Clennon voted nay.

The Committee-of-the-Whole had an extended discussion at the last work session regarding hirings for two vacant positions: full-time children's librarian and Street Department employee. The Committee-of-the-Whole recommended filling the positions.

Moved by Council Member Boughton, seconded by Council Member-at-Large Anderson, authorizing the hiring for a full-time children's librarian. 4-3. Carried. Voting nay: Council Members Enright, Clennon and McAlister.

Moved by Council Member King, seconded by Council Member-at-Large Anderson, authorizing the hiring for a Street Department employee. 4-3. Carried. Voting nay: Council Members Enright, Clennon and McAlister.

Moved by Council Member Austin, seconded by Council Member Enright, authorizing an estimated \$10,000 from 2011 Contingency Fund for Riverside Arena boiler repair. Carried.

The Committee-of-the-Whole has discussed and recommended approval of amendments to the Policy for Authorized Uses of Fire Department Vehicles.

Council Member Clennon moved to table this matter to look at other departments' use of city vehicles being used for other things. She believes this policy should be made more comprehensive instead of just one department. Motion seconded by Council Member Enright. Carried. 4-3. Voting nay: Council Members McAlister, Austin and King.

Moved by Council Member Enright, seconded by Council Member King, adopting a resolution granting Sunday Hard Liquor On-Sale License for Hormel Historic Home, 208 4th Avenue NW. 7-0. Carried.

And if the ground is frozen, a temporary sign will be placed.

Council Member Clennon recently found that the Humane Society was full, as was the animal control. She urged that the pound project to move ahead or we will have many homeless animals.

Mayor Stiehm thanked everyone for a very good year.
