The City plans on removing the plaza area, utility upgrades, LED lighting, decorative sidewalk, pedestrian curb ramps, drive-over curb and concrete paving.

Administrative Services Director Tom Dankert requested Council support on a proposed housing project the HRA has been working on with Three Rivers Community Action. There is a need for workforce housing in Austin and the HRA would like to take the lead on the project to create approximately 30 units of housing. Mr. Dankert requested support of a tax increment financing district for the development.

Moved by Council Member Enright, seconded by Council Member-at-Large Anderson, adopting a resolution in support of the Housing and Redevelopment Authority and Three Rivers' housing project including tax increment financing for the project. Carried 7-0.

Director of Public Works Steven Lang provided an estimate of \$1,635 for shared bike/vehicle lanes on 4<sup>th</sup> Street SW from 1<sup>st</sup> Avenue SW to the Turtle Creek bridge and on 16<sup>th</sup> Avenue SW to 31<sup>st</sup> Street SW. Bike symbols would be placed every 120 feet and after each intersection. The proposed bike lanes would tie into the current City's trail system. The roads are County roads and the project is subject to County approval.

Moved by Council Member Enright, seconded by Council Member King, authorizing on-road bike lanes. Carried.

Moved by Council Member Austin, seconded by Council Member-at-Large Anderson, adopting a resolution establishing the Pillars of the City flood wall of recognition committee. Carried 7-0.

Council Member King stated the Community Pride Clean Up Day went very well and thanked the volunteers and Park and Rec Director Kim Underwood for her hard work.

Public Works Director Steven Lang stated there was a large rain event in Austin the night before where the City received two inches of rain in a short time period. City crews responded to street issues immediately following the event. He also noted that 8<sup>th</sup> Avenue NE and 8<sup>th</sup> Street NE is now closed for street reconstruction.
