# Item No. 1 – Work Force Housing

Housing and Redevelopment Director Jon Erichson provided Council with an update on workforce housing in Austin. The HRA is continuing to with Three Rivers Community Action to apply for 2016 tax credits to be used for a workforce housing project at Fox Pointe. In 2015, the Council approved tax increment financing for the project but the project was not awarded funding from the State. The HRA is once again going to apply for a State grant for the project with the application being due in June of 2016. The Hormel Foundation has committed to matching funds for the purchase of the property up to \$175,000 and the HRA Board is in support of the project.

One change to the project is that the number of units has increased from 30 to 38 units. The decision from the State on the grant application will be made in October of 2016. Construction would take place in 2017 if the project is approved. The property would need to be replatted and other issues with surrounding property owners worked out.

Mr. Erichson requested the Council reaffirm their support of the project and to modify the units to 38 units.

Moved by Council Member King, seconded by Council Member Hagen, reaffirming Council participation in a 38 unit HRA workforce housing project a Fox Pointe. Carried.
