#### **PUBLIC HEARINGS:**

A public hearing was held for the proposed abatement of taxes for No Reh and Su Meh through the Austin Homes Initiative Program. City Administrator Craig Clark stated they are building a new home valued at approximately \$368,000 in Austin and requested that the taxes on the improvement value of the home be abated under the Austin Homes Initiative. The abatement would be in the approximate amount of \$8,980 over the five year period.

There were no public comments.

Moved by Council Member King, seconded by Council Member Fischer, adopting a resolution approving a five year tax abatement request for No Reh and Su Meh. Carried 6-0.

## PETITIONS AND REQUESTS:

Public Works Director Steven Lang presented informal bids for the exterior door replacement at Riverside Arena. Mr. Lang stated there were two bidders on the project – Wagner Construction at \$72,300 and the Joseph Company at \$76,900. The project will be funded 50% through a Hormel Foundation grant and 50% through the general levy. Mr. Lang recommended awarding the bid to Wagner Construction Company.

Moved by Council Member-at-Large Anderson, seconded by Council Member Hagen, appointing Oballa Oballa to the Human Rights Commission, term expiring 12/31/17. Carried.

Moved by Council Member King, seconded by Council Member Austin, adopting a resolution accepting a Hormel Foundation grant to the City of Austin. Carried 7-0.
