Director of Public Works Steven Lang presented the 2018 assessment rates stating it is the City's goal to assess adjacent property owners 50% of the costs of street projects. He proposed increasing the assessment rates for urban and commercial streets 3%. Therefore, the rate for 2018 will increase from \$44.00 per lineal foot to \$45.25 per lineal foot for residential street reconstruction and \$63.00 per lineal foot to \$64.75 per lineal foot for commercial properties. The sidewalk rate will also increase from \$4.75 to \$5.25 per lineal foot. Other rates would also be increased.
