Mayor Stiehm called the meeting to order at 5:30 p.m.

Moved by Council Member King, seconded by Council Member Fischer, approving the agenda. Carried.

Moved by Council Member Enright, seconded by Council Member King, approving the Council minutes from May 21, 2018. Carried.

Moved by Council Member Enright, seconded by Council Member Austin, approving the consent agenda as follows:

PETITIONS AND REQUESTS:

Administrative Services Director Tom Dankert requested the Council approve the 2017 audit findings. He stated Kim Hillberg from CliftonLarsonAllen, LLP presented the audit at the May 21, 2018 work session and stated everything is in order and no findings occurred during the audit. He noted in the General Fund the City was within 0.11% of hitting the revenue budget, and within 3% of hitting the expenditure budget.

Moved by Council Member-at-Large Anderson, seconded by Council Member Austin, approving the 2017 audit findings. Carried.

Moved by Council Member Enright, seconded by Council Member King, adopting a resolution accepting donations to the City of Austin. Carried 7-0.

Public Works Director Steven Lang requested the Council authorize an access agreement with WEC Energy Group for the former Holiday Dodge site located near the intersection of Oakland Avenue East and 4th Street NE. The property was cleaned up by Alliant Energy in 2008 but some additional contamination has been discovered. WEC Energy Group would like to do an additional round of testing in June/July and do a site cleanup in September. The cleanup area would include some of the Cedar River.

Council Member Enright asked if the work will interfere with the bike trails in the area.

Mr. Lang stated the bike trails will need to be closed or rerouted while work is taking place.

Moved by Council Member King, seconded by Council Member Austin, approving an access agreement with WEC Energy Group. Carried 7-0.

Director of Administrative Services Tom Dankert stated the Governor signed the omnibus retirement bill on May 31st. The City's 2017 State Fire Aid in the amount of \$129,000 is included in the bill and the City must pass a resolution approving the new bill and submit a certificate of approval to the Secretary of State to ensure payment. Mr. Dankert noted the 2018 omnibus budget bill was vetoed which included repayment of the 2016 State Fire Aid in the amount of \$129,000. He has already contacted Senator Sparks and Representative Poppe about having the repayment included in the 2019 legislative session.

Moved by Council Member-at-Large Anderson, seconded by Council Member Helle, authorizing Minnesota Laws 2018, Chapter 211, Article 14, Section 26. Carried 7-0.

Police Chief Brian Krueger Requested the Council approve a police liaison officer agreement with Independent School District No. 492 for two officers during the 2018-2019 school year.

Moved by Council Member King, seconded by Council Member Fischer, approving a police liaison officer agreement with Independent School District No. 492. Carried 7-0.

Moved by Council Member Hagen, seconded by Council Member King, declaring the property at 408 8th Avenue SE a hazardous structure. Carried 7-0.

Planning and Zoning Administrator Holly Wallace noted the property at 307 7th Street NE has been cleaned up and should be removed from the agenda.

Moved by Council Member Enright, seconded by Council Member Austin, granting the Planning and Zoning Department the power to contract for the removal of junk and/or illegally stored vehicles at 1104 11th Avenue SW, Jones Property. Carried.

Moved by Council Member Enright, seconded by Council Member Austin, granting the Planning and Zoning Department the power to contract for the removal of junk and/or illegally stored vehicles at 2009 6th Avenue SW, Smith Property. Carried.

REPORTS

Council Member Helle stated June 5th is the last day to file for public office. She stated she would like to see more diversity in the leadership of Austin.

Council Member-at-Large Anderson stated that 4th Avenue Fest will take place on June 13th from 5-8:30 p.m. at Horace Austin Park.

City Administrator Craig Clark stated the Governor signed the bonding bill for 2018.

Library Director Julie Clinefelter stated summer reading begins on June 11^{th} and kids can sign up at the library. She also stated librarian Kathy Helle is retiring and an open house will be held on Thursday, June 7^{th} from 1:00-2:00 p.m.

Parks and Recreation Director Kim Underwood stated the pool opens at 1 p.m. on Monday, June 11th and will feature two new slides and a bouncy swing in tot pool.

Police Chief Brian Krueger state Detective Mark Haider is retiring from the department with 33 ½ years of service.

Moved by Council Member Austin, seconded by Council Member King, adjourning the meeting to June 18, 2018. Carried.
