- Beads on a String Commissioner Beckman reported that about 150 people attended.
- Human Rights Conference on December 3 Commissioner Moritz reported she very much enjoyed the Q&A with Coach Boone and the GLBT session. Commissioner Vela commented on a great Immigration Relief session and on Coach Boone, Commissioner Wald stated

Coach Boone and also learned a lot in a session about Islam, Commissioner Langrell highlighted Coach Boone's address. Commissioner Stewart had attended as well.

- Know Your Rights Training The Advocates for Human Rights will be doing this training after MLK.
- MLK celebration The Frank W Bridges Theatre is arranged. Josie Nelsen, the essay winner, will be asked to read her essay. Students from CORE will read excerpts from the book 'Letters from Mississippi'. Music is still to be arranged. This is the 25<sup>th</sup> year of MLK Day as a federal holiday. Some communities use the day off as an opportunity for community service. We'd like to think of 25 ideas for service and send out a week prior in Hy-Vee grocery bags.

#### 6. Other Business

- Bullied The AHS diversity club, now the gay/straight alliance, want to do a week long education using the film 'Bullied'. The film is about a student who was bullied in middle school and sued his school district. The subject of the film will come and speak. Due to the related chemical use, CHAI will pay for his presentation. The night before the school presentation there will be a public presentation. Some other partners are interested in funding also.
- Paramount Theater The Paramount Theater is considering partnering with us for a film.
- CORE CORE is trying to put together a multi-district meeting for a day of leadership training. With a goal of maybe four or so groups to participate.
- Email list A discussion about if it would be possible for people to be on an email list from our website (besides Facebook) to receive alerts of activities and events.
- School Calendar Change A short discussion on how a possible change in school calendar could affect future MLK Day activities.
