## 8. Citizens Addressing the Commission

Matthew Simonson stated his concerns about human rights, the Rwanda dictatorship, the US has the highest prison population, unemployment of blacks shows discrimination, Austin's new government policies take from the poor and give to the rich, there is decreased liberty, equality, and justice, decreased democracy, Jim Hurm was praised in the Herald for withholding important information from the voters, and that he is in contact with the State Human Rights Commission. He submitted a copy of a letter to the MN Dept of Human Rights which is dated 2/9/12.

Dan Kane addressed the commission. He questions what is the total amount of dollars spent by HRC for MLK. Asked if the Bogott's have received their award. States he is glad we are not going to do savings bonds. Notes that in the past HRC has spent about \$100.00 on the essay contest and now it well be about \$250.00. Wants to know if we would consider recognizing more children. States that using Commissioner Lindbloom for the Sudan event is a good idea, but also someone with life experience from Sudan.
