# Human Rights Commission Minutes of June 26, 2012

### 4. The Advocates for Human Rights

Madeline Lohman presented information about 'One Voice Minnesota Monitoring Project - Creating a Blueprint for Welcome'. She handed out a pamphlet and spoke for several minutes and we held discussion.

The data collected will help determine the issues facing immigrants and how we can create change in systems that are fueling these problems. The methods include voices and experiences of their partner organizations. The Advocates is hoping Austin HRC is interested in a one year pilot for greater Minnesota outreach. We could host community conversations, meet with all law enforcement, conduct media monitoring, and do follow up activities; all information is anonymous.

Resulting goals will be decided by The Advocates in early 2014.

Commissioners discussed and decided this would be a good opportunity and we would continue to talk at our next meeting. Perhaps we can start this fall.

#### 5. Other Business

We discussed the summer meeting schedule. Commissioner Stewart moved that we not meet in July, but that we meet on our regular schedule in August, Commissioner Vela second, motion passed unanimously.

There is an opening on the Commission. Commissioner Langrell is moving and no longer eligible to serve.

Commissioner Martin handed out packets of hand-outs that were available at the Paramount Theater during our film festival.

Ms. Lohman talked about President Obama granting temporary status to young immigrants. The Advocates will have a list of lawyers and resources; fraudulent offers for legal help are a concern.
