- 3. Budget Current operating budget balance is \$374.86 budgetary expenses included \$62.50 for the Zonta advertisement in the Austin Daily Herald for domestic violence awareness.

New Business

- 4. Vickie Spyhalski, incoming Commissioner, and Bukata Hayes of the Greater Mankato Diversity Council presented on a journaling project called "Write on Race". It was a project in which people of Mankato participated over a two-year period in which they journaled on racial equity and historical policy impacts on people of color. Discussion was centered on the possibility of organizing a similar group within the city of Austin and if AHRC would be interested in sponsoring or partnering with other organizations. Bukata presented his work and provided information on the details of what this endeavor would entail. Commissioner Braaten motioned and Commissioner Karki seconded to spend the remaining 2020 budget on a promotional advertisement of the event on the Austin Daily Herald and a Facebook boost. Motion passed unanimously.
- 6. Podcast Subgroup Nothing to report at this time but hope to have more information after the subgroup can meet again.
