A house built in 1952 sold last year in Mower County with covenant stated no people of color could purchase houses in the neighborhood. Met Mayor of city north of St. Paul was interested in hearing about our Human Rights Commission because his city is trying to form their own HRC. The conference was a place to deliberatively talk about race.

Commissioner Hartman – will look into covenants in Mower County with some realtors in town. City Liaison Wiechmann will ask someone from Planning and Zoning if there are any covenant laws still in place in Mower County.
